

ORDER CALLING GENERAL ELECTION FOR THREE DISTRICT DIRECTORS

WHEREAS, the Board of Directors (the "Board") of the High Plains Underground Water Conservation District No. 1 ("HPWD" or "District") has the authority pursuant to Chapter 36 of the Texas Water Code to call a General Election on November 3, 2026, which is a uniform election date, to elect three (3) Directors to the Board of the HPWD ("Directors") to serve four (4) year terms as follows:

- one (1) Director for Precinct One (1) from the territory of HPWD in the portion of Crosby County within the district and all of Lubbock and Lynn Counties,
- one (1) Director for Precinct Two (2) from the territory of HPWD in the portion of Hockley County within the district and all of Cochran and Lamb Counties,
- one (1) Director for Precinct Five (5) from the territory of HPWD in the portion of Floyd County within the district and all of Hale and Swisher Counties; and

WHEREAS, the Board also has the authority pursuant to Chapter 271, Texas Election Code, to enter into joint election agreements with the other political subdivisions also holding an election on the same date, and in the same territory; and,

WHEREAS, the Board also has the authority pursuant to Chapter 31, Texas Election Code, to enter into a contract for election services with Cochran, Crosby, Floyd, Hale, Hockley, Lamb, Lubbock, Lynn and Swisher Counties, Texas.

IT IS, THEREFORE, ORDERED BY THE BOARD OF DIRECTORS OF THE HIGH PLAINS UNDERGROUND WATER CONSERVATION DISTRICT NO. 1 THAT:

Section 1. Call of Election: Date: Eligible Electors: and Hours. A general election (the "Election") shall be held on Tuesday, November 3, 2026, which is seventy-eight (78) or more days from the date of the adoption of this order (the "Order"), within the territory of the District at which all resident, qualified electors of HPWD Precincts One (1), Two (2), and Five (5) shall be entitled to vote. The general election shall be for three (3) Directors to serve for full terms of four (4) years on the Board of the District. The Election shall be held as follows:

- A general election shall be held in the territory of HPWD within the portion of Crosby County above the escarpment within the district and all of Lubbock and Lynn Counties;
- A general election shall be held in the territory of HPWD within Cochran and Lamb Counties and the portions of Hockley County within the district; and
- A general election shall be held in the territory of HPWD within the portion of Floyd County above the escarpment and all of Hale and Swisher Counties.

The Board hereby finds that holding the Election on such date is in the public interest. The hours during which the polling places are to be open on Election Day shall be from 7:00 a.m. until 7:00 p.m.

Applications for a Place on the Ballot for the general election must be received by 5:00 pm August 17, 2026. The candidate in each position receiving the highest number of votes cast by the electorate shall be elected Director for that respective position.

Section 2. Conduct of Election. The Election shall be conducted by election officers, in accordance with the Texas Election Code, Texas Water Code and the Constitution and laws of the State of Texas and the United States of America. Each respective County's voting system shall be used in the election conducted in that County.

Pursuant to Chapter 31 and Chapter 271 of the Texas Election Code, the Board orders that the Election be conducted under the terms and conditions of election services contracts with Cochran, Crosby, Floyd, Hale, Hockley, Lamb, Lubbock, Lynn and Swisher Counties, and the joint election agreements with the counties and other political subdivisions which will be approved by the Board when available.

Chapter 271 of the Texas Election Code provides that the authorities of two or more political subdivisions that have ordered elections for the same day in all or part of the same territory, may enter into an agreement to hold the elections jointly in election precincts that can be served by common polling places, and the Board is expressly authorizing this action.

The Board of Directors hereby approves the election day presiding judge and alternate presiding judge, as well as all early voting clerks for each polling location as appointed by the Election Administrator or County Clerk of each county involved in the Election.

Section 3. Voting Precincts. Except as otherwise provided in this Order or any included Exhibits, the currently existing boundaries and territory of the respective Cochran, Crosby, Floyd, Hale, Hockley, Lamb, Lubbock, Lynn and Swisher County election precincts, that are wholly or partially within the territorial boundaries of HPWD are hereby designated as the voting precincts of HPWD for the Election. The precinct numbers for HPWD's election precincts shall be the corresponding County election precinct number for each precinct. If any County utilizes vote centers for their elections, then all vote centers used in said County will be the early voting and election day voting locations for the Election.

Section 271.003 of the Texas Election Code provides that voters of a particular election precinct or a political subdivision may be served in a joint election by a common polling place located outside the boundary of the election precinct or political subdivision if the location can adequately and conveniently serve the affected voters and will facilitate the orderly conduct of the election. To the extent any polling place utilized by HPWD in the conduct of the Election is located outside the boundaries of the election precinct or HPWD for any election precinct, the Board specifically finds that the polling place selected is convenient and will adequately serve the voters of the district. The list of election day polling places, for each County will be approved by the Board when available.

Section 4. Early Voting. The Board appoints Jennifer McClendon as HPWD's Regular Early Voting Clerk. Joint Early Voting Clerks shall be those appointed under the joint election agreements.

Early Voting by Personal Appearance

Early voting by personal appearance in each County shall be conducted Monday, October 19, 2026, through Friday, October 30, 2026. The times and locations for early voting, including the main early voting locations, will be approved by the Board when available.

The Regular Early Voting Clerk for HPWD shall collect all applications for ballots received by HPWD at the above address up to the deadline to receive an application which is October 23, 2026 and shall deliver all such applications to the Joint Early Voting Clerks.

Section 5. Delivery of Voted Ballots; Counting; Canvassing; Declaring Results. In accordance with the requirements of the Texas Election Code, after the close of voting on election day, the presiding election judges for each respective precinct shall deliver the ballot boxes for their respective precinct to the central counting stations in each county. Each County early voting ballot board, at a time and in the manner permitted under the Texas Election Code, shall deliver the early voting ballots to the County central counting stations. The joint election officers, as HPWD's designated election officers under the joint election agreements, shall make a written return of the Election results to HPWD in accordance with the Election Code. The Board shall canvass the returns and declare the results of the Election.

Section 6. Appointment of Custodian of Records. To the extent not otherwise provided for in election services contracts, or in any joint election agreements, the Board appoints Gray Sanders, an employee of HPWD, as the Custodian of Records ("Custodian") to perform the duties related to the conduct and maintenance of records of the Election as required under the Texas Election Code during the period beginning the fiftieth (50th) day before and ending not earlier than the fortieth (40th) day after the day of the Election. In particular, the Custodian shall provide applications for candidates, accept applications from candidates for a place on the ballot, determine the order in which names will appear on the ballot for the director positions and accept and maintain records regarding campaign expenditures that may be filed with the district.

The Custodian shall maintain an office open for election duties for at least three hours each day, during regular office hours, on regular business days during the periods designated in this section. The Custodian shall post notice of the location and hours of his office as required by the Texas Election Code. The Custodian shall maintain in his office, the documents, records and other items relating to the election and shall be the person designated to receive documents on behalf of HPWD that are required by the Texas Election Code.

Section 7. Appointment of Agent. The Secretary to the Board has appointed Jennifer McClendon as the Secretary's agent ("Agent") to perform the duties of secretary related to the conduct and maintenance of records of the Election as required under the Texas Election Code. Ms. McClendon is authorized to designate staff in the District to perform any or all of the various responsibilities of the Board's Agent or Custodian.

The Agent shall maintain an office open for election duties for at least three hours each day, during regular office hours, on regular business days during the period designated in this section. The Agent shall maintain the documents, records and other items relating to the election and shall be the Agent designated to receive documents on behalf of the District that are required by the Texas Election Code.

The Agent shall post notice of the location and hours of the office as required by the Texas Election Code.

Section 8. Notice of Election. Notice of the Election, stating in substance the contents of this Order, shall be published one time in the English and Spanish languages, in a newspaper

published within HPWD's territory at least 10 days and no more than 30 days before the Election and as otherwise may be required by the Texas Election Code. Notice of the Election shall also be posted on the bulletin board used by the Board to post notices of the Board's meetings, and on the District's website no later than the 21st day before the Election.

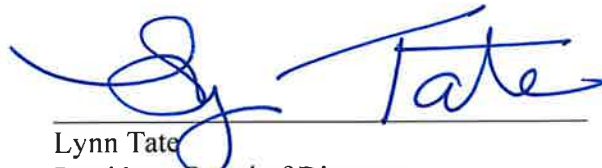
Section 9. Election Information to be provided in Spanish. The Agent shall be responsible for the preparation of notices, instructions, orders, ballots and other written material pertaining to the Election and shall cause each such document to be translated into and furnished to voters in both the English language and the Spanish language in order to aid and assist voters speaking Spanish as a primary or an alternative language to properly participate in the election process. In addition, the Agent is hereby authorized and directed to make available to the voters having the need of an individual capable of acting as a translator and speaking both English and Spanish languages who will assist Spanish speaking voters in understanding and participating in the election process.

Section 10. Training of Election Officials. Pursuant to the Election Code, a public school of instruction for all election officers shall be held as arranged or contracted by the HPWD Election Officer or the joint election officers.

Section 11. Authorization to Execute. The President of the Board is authorized to execute and the Vice President of the Board is authorized to attest this Order on behalf of the Board; and the President of the Board is authorized to do all other things legal and necessary in connection with the holding and consummation of the Election.

Section 12. Effective Date. This Order is effective immediately upon its passage and approval.
